

# **Terms and Conditions**

## **Shipping**

Trade terms of all orders shall be Ex Works (Incoterms 2000). All shipping charges shall be prepaid and added to the customer's invoice. Notify Wealtec directly in the event of any incorrect or damaged material within 7 days of receipt to avoid being charged reshipping or handling fees and to get pre-authorization for any potential replacements.

## **Payment Terms**

Payments for orders are accepted by T/T, Visa, Master, and American Express credit cards, after credit review by Wealtec. Wealtec has the right to decline a method of payment after its review. Terms of payment are PREPAIMENT. All orders are subject to confirmation by Wealtec and to products availability.

## **Returns**

Upon customer's receipt of goods shipped hereunder, customer shall inspect the goods and notify Wealtec's Support of any claims for shortages, defects or damages. If customer fails to notify Wealtec's Support within three days after customer receive the products, the products shall conclusively be deemed to conform to these Conditions and to have been irrevocably accepted by customer. Authorization for all product returns must be approved by Wealtec's Support and a RMA (Return Merchandise Authorization) number given to customer prior to the return of products. Not all items will be authorized for return, due to packing requirements. Items authorized for return must arrive at Wealtec's facilities in a state satisfactory for resale to be eligible for product credit. A restocking charge of 25% or \$25, whichever is greater, shall be charged no returns that are not the result of any error or fault of Wealtec's. Shipping charges will not be credited. Products may not be returned for credit after 20 days after customer's receipt of the goods.

## Warranty

Products except consumables are guaranteed to be free of defects in material and workmanship for one (1) year from the date of invoice; consumables are guaranteed to be free of defects in material for three (3) months from the date of invoice.

The liability of Wealtec under this limited warranty does not extend to any products, in our sole discretion, that are abused, altered, or misused by the customer or any other persons or which become defective or non-conforming through the actions or inaction of the customer or any other persons.

THIS WARRANTY IS EXCLUSIVE, AND WEALTEC HERREBY DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.

If any products warranted hereunder proved defective or non-conforming, Wealtec's exclusive and sole liability and customer's sole remedy shall be for Wealtec, to repair or, at Wealtec's option, to replace at no cost to customer, upon the return of such goods in accordance with our instructions.

IN NO EVENTS SHALL WEALTEC BE LIABLE UNDER ANY LEGAL THEORY (INCLUDING BUT NOT LIMITED TO CONTRACT, NEGLIGENCE, STRICT LIABILITY IN TORT OF WARRANTY OF ANY KIND) FOR ANY INDIRECT, SPECIAL INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES (INCLUDING BUT NOT LIMITED TO LOST PROFITS), EVEN IF WE HAD NOTICE OF THE POSSIBILITY OF SUCH DAMAGES.

If Wealtec manufacture products for customers based on instructions, specifications, or other directions provided to us, we shall not be liable for the lack of sufficiency, fitness for purpose or quality of the products to the extent attributable to such instructions, specifications, or other directions. Wealtec shall not be liable for any loss, damage or penalty as a result of any delay in or failure to manufacture, deliver or otherwise perform hereunder due to any cause beyond our reasonable control.
